## POST JAMBORETTE HOME HOSPITALITY SCHEME NOTES FOR REGIONAL CO-ORDINATORS

Home Hospitality is an important aspect of the overall Scottish International Patrol Jamborette experience and in order to assist you, the Scouts, and their families in preparing for this, detailed notes have been prepared.

The attached Post Jamborette Hospitality Scheme schedule provides details of the arrangements for Home Hospitality after the Jamborette. This information should be made available to everyone in the Region who will be involved with Home Hospitality, including all host families.

This year, we have also prepared "Notes for Hosts". These notes will hopefully assist in the families' preparations for Home Hospitality.

Child Protection is a vitally important aspect of all that we do and your assistance is requested in ensuring that the Scout Association Policy is adhered to in relation to the Home Hospitality arrangements.

The Scout Association requires that all parents & guardians where Scouts will be during Home Hospitality must be subject to the Scout Association's vetting procedures and have either an existing Disclosure Scotland **secured through Scouting**, become PVG Scheme members or update an existing PVG Scheme membership. Other adults who live at the property i.e. brothers and sisters - albeit over 18 years of age - are **NOT** in scope of the current legislation and cannot be asked to become PVG Scheme members.
