### **JOINING INSTRUCTIONS**

For those who have never been to Satellite Camp before, the programme will include taking part in the activities available to Scouts during the camp, participation in the international country fair on the Saturday afternoon and involvement in the international campfire on Saturday evening. You will be part of the Scouts Own Service at the castle on the Sunday morning and will join in 'Satellantics' with the Overseas Leaders on the Sunday afternoon before a barbeque meal and evening activities with everyone at the Satellite Camp.

There are also a number of events which will take place on the Satellite site itself and I can guarantee that there will be something new for everyone from first time Satelliters to those who are making a welcome return to Blair Atholl.

We have emailed various forms, some for information and some which need to be returned. We would be pleased to have the tent info sheet, nominal roll and country fair details returned as soon as possible, but not later than **the 30<sup>th</sup> June 2022**.

Can I remind everyone that cooking will be on gas burners only so please ensure you bring an adequate supply for your burners. **Please note also that all groups will be asked to loan their burners and gas to the main site for the country fair on the Saturday.**

The format for the organisation of the Satellite activities at the country fair on the Saturday afternoon is the same as 2018. We will be asking a number of groups to combine to provide an activity. You will find details of this on the country fair form. This has been done as we have been asked to provide **only ten activities** this year from the Satellite Camp.

Arrival at camp on Friday 22<sup>nd</sup> July can be from 12.00 onwards and I would ask all leaders to note their arrival time on the tents info sheet. The main Jamborette is open to Satellite Campers from 14.00. Departure on the Monday is expected to be by noon.

Scouts and Explorers have the chance to complete their Mission Card on the Friday afternoon which lets them explore the main site and the Satellite Camp. These cards will be issued on arrival.

The Friday evening will be spent on the Satellite Camp with a number of new and different activities planned. All Scouts/ Explorers will be issued with a satellite camp neckie on arrival. **This neckie must be worn at all times.**

## **SAFEGUARDING OF ADULTS AND YOUNG PEOPLE**

As leaders in Scouting, we all have responsibility for Child Protection. The Application Form and registration process is all part of what we need to do, as is the identity badge, which will be issued to all staff. All visitors to the site **MUST** be properly signed in and out, and under no circumstances can anyone who is not registered in advance of the camp stay overnight on the camp.

The Scout Association's 'Young People First' (The Yellow Card) code of good practice must be adhered to during the Jamborette. All adults on the Camp have a responsibility to ensure that young people are protected from harm. It will be the responsibility of each adult to ensure that:

- their behaviour is appropriate at all times
- they observe the rules established for the safety and security of young people
- they follow the procedures following suspicion, disclosure or allegation of child abuse
- they recognise the position of trust in which they have been placed
- in every respect, the relationships they form with young people in their care are appropriate
- the welfare of all young people is safeguarded
- they avoid compromising situations or opportunities for misunderstandings or allegations

The code of practice summarised above is to protect both Young People and Adults so that they can all experience the challenge and adventure of the Jamborette in the most positive way possible.

## **PVG STATUS / CAMP PASSES**

As previously intimated on your acceptance letter, all adults over the age of 18 attending the Satellite Camp (as well as those attending the main Blair Atholl Jamborette) are required to hold a current Protection of Vulnerable Groups Certificate (or disclosure certificate) secured through Scouting. This includes those coming as Leaders/Others or Network members. In addition, all leaders must have completed the training required for their role in Scouting.

Therefore, please send us as soon as possible (and by the 30<sup>th</sup> June at the latest) a list of

the:

- The names of each of the adults attending with your party and a head and shoulders photograph.
- their Scout Membership Number (where applicable) and
- the date of their PVG. The PVG number is not required.

This information should all be sent to : **Satellitecamp@jamborette.org.uk**

These will be checked as part of the registration process prior to the camp and passes and photographic passes will be produced for all over 18's. **Anyone without a valid PVG or who does not submit a photograph with their information will not be allowed to participate.**

This pass also allows access to the Staff Club on the main site and will be issued free of charge from Satellite reception on arrival.

### **FORM NAN / PERMISSION TO CAMP FORMS / MEDICAL FORMS / etc.**

It is the responsibility of each group attending to complete all the necessary paperwork required for taking your group to camp. This includes Form NAN's, etc. Help can be provided on completing these but they should be submitted locally. Groups must also have permission to camp forms, medical forms, etc. for all their participants. The satellite camp takes no responsibility for the completion or collection of these forms.

### **ALCOHOL POLICY**

The Scout Association has issued all leaders with a copy of the 'Green Card', a revised checklist on **Scouting and Alcohol & Scouting** (available online at <https://cms.scouts.org.uk/media/6744/scouting-and-alcohol-green-card.pdf>) which I have been instructed by the Senior Camp Staff to bring to your attention.

**Please read this carefully as this policy applies fully.** It should be noted that whilst the Satellite Staff are responsible for the Sub-Camp they are **not responsible for your youngsters** – that remit remains with you and as such the Scout Association policy must be followed.

As an adult in Scouting, you are a role model for young people. In certain circumstances drinking alcohol has the potential to place adults in a compromising position with regard

to their responsibilities for child protection and their duty of care.

All adults need to be physically and mentally fit to undertake their responsibilities in this area.

**When responsible for young people, adults must not drink alcohol.**

During Scouting events that are attended by under 18s, the following should apply:

- Under 18s **must not** drink alcohol under any circumstances.
- At any one time there should be the correct ratio of responsible adults (in accordance with POR) who must not consume alcohol.
- If you are not directly responsible for young people, and you do drink alcohol, you should still follow the Yellow Card (our safeguarding code of practice).
- **If you are drinking when 'off duty', you should consider how alcohol may affect your ability to carry out your Scouting duties when back on duty.**
- Young people must know who is responsible for them at all times
- **It is not permitted to walk around site with any alcohol.**

As the UK's Premier International Camp, it is also important that all staff / leaders:

- Consider the cultural and religious observances or needs of those taking part in the event.

In addition, Rule 2.4d in POR, states that “**Adults must not consume alcohol when they are directly responsible for young people on a Scouting activity**”. Whilst the participants are onsite we also expect all staff to follow the good practice advice from the Alcohol and Scouting Factsheet which states “**any adults who do consume alcohol must not interact with young people and should be 'off duty'.**”

Any inability to carry out their Scouting duties, efficiently perform camp duties or exercise proper judgement as a result of alcohol consumption is a serious matter and the Senior Staff **will** take action.

## SCOUTS OWN

If you have your own Group Flags these may be paraded on the Sunday morning for Scouts Own.

## CODE OF CONDUCT:

The Code of Conduct for the Jamborette is based upon the standard Code of Conduct for International Events used by the World Bureau. It is a general code and additions can and will be made at the camp as required. As with all Scouting activities, the camp operates under the provisions of the UK Scout Association's Policy, Organisation and Rules (POR) and the Scottish Variations thereof.

All staff members (Scottish and Overseas) at the Blair Atholl Jamborette must agree to follow and adhere to the Code of Conduct below.

Please follow these guidelines to keep yourself and everyone else safe and help us all have a great Jamborette.

- Wear your Jamborette neckie and I.D. badge at all times unless asked to remove them for safety reasons.
- Follow the **Scout Promise, Law and Fundamental Values** at all times.
- Be tolerant, respectful and understanding of others.
- Turn up for your duties on time. If you are unable to work, you must make sure your team leader knows before you are due to start.
- Respect other people's property - if you didn't bring it or buy it, then leave it alone. 'Trophy hunting' is theft!
- Smoking is permitted only in marked areas.
- The possession, use or supply of illegal substances is expressly forbidden.
- As an adult you may not swap badges with Participants. You may not sell anything.
- Please respect the right of others to sleep and rest. Remember that people will be working shift patterns and may have to sleep during the day.
- Please use the bins provided and make a special effort to keep the Jamborette clean and tidy.
- Take care when using the services such as showers and toilets and think of others.

- Gambling is not allowed.
- Please respect and follow all signs and instructions - 'out of bounds' or restricted access areas have been designated for a reason.
- The Staff Lines, Staff Mess and Staff Club are for staff members only.
- Staff should wear full Scout Uniform or appropriate activity dress when off-site unless otherwise instructed by the Core Team.

The UK Scout Association has a [Child Protection Policy](#), [Safety Policy](#) and guidelines on "[Scouting and Alcohol](#)" and the "[Scouting and Alcohol - Green Card](#)". All persons present at the Jamborette must familiarise themselves with the content and abide by these rules whilst on the site.

All Staff members must follow direction from the Camp Chief, as the Regional Commissioner for the event, and his Core Team.
