Pre-existing medical conditions	All	Participants to be requested to notify these to a Permit Holder or Activity Helper as they leave Subcamp. Permit Holder to ask again at the beginning of session. Remoteness including lack of phone signal (for gaining emergency assistance)	All	In an emergency it may not be possible to contact the main site or the emergency services. Lack of a secure changing area	All	Participants to be instructed not to bring valuables to Faskally site where possible. Any valuables which are brought and cannot be taken on the water, should be locked inside site emergency vehicle.	Activity Leader	4
