

Due to the nature of the organisation not everyone has mobile plant tickets such as CPCS however have operated mobile plant within work places such as Agricultural Settings, Construction Sites, Waste and Quarry Operations. Keys for mobile plant to be removed when not in operation and returned to the key boards. If people are tired or unfit it is critical they do not operate mobile plant at anytime. 	
 Maintenance Oils & Greases (Carcinogens) Fuel Scalds & Burns 	Adults Maintenance Contractors	 Pre start checks to be done on all equipment daily. Specific tasks such as adding coolant, oils and greasing can be done by a competent individual. Plant to be filled up on site from portable bowser or at Atholl Estate Farms. Only individuals trained on how to operate the bowser can fill up mobile plant. Petrol will be stored in jerry cans and kept in site compound. Mobile plant which is fuelled at home farm can only be carried out by competent individuals. Spill kit on site to contain any fuel spillage. If a more serious mechanical issue the hire company will be contacted to carry out a repair to the machine. This will be done on a safe area on site.
